HISTORIC LANDMARK

The Bicentennial celebration of our country has sparked interest in the history and heritage of our communities. Last October, there was an article in the Plymouth PILOT-NEWS concerning the oldest businesses in Marshall County and in the state. The Historic Landmark Foundation of Indiana designated the Grossman Funeral Home as the "oldest continuously operating business relocated to a new site or building....In the state, Grossman Funeral Home is the states third oldest funeral home."

Otto L. Grossman, great uncle of Robert Grossman, started the Grossman business heritage in 1897. He was then an apprentice to his uncle, Mr. A. Wickizer. In 1898, Otto bought the business from his relative and, having one of the first of 200 embalmer licenses issued by the state, started the Grossman home.

The early mortuary was located in a frame building on Walnut Street. Argos. After eight years, Otto built a three story brick building at 108 North Michigan Street for the funeral home and for his furniture business.(Until recently, this location was the Crabb Furniture Store.)

"Here he entered boldly into the furniture business with a heavy stock which filled the huge first-floor display room. But the undertaking business was not put in second place. It was only the natural union of the two lines of business. Furniture and undertaking were not strangers to each other in Indiana.

"The funeral home idea had not yet caught on, services being held in homes or churches. But it was in the air and in addition the undertaker was soon to be replaced by the modern funeral director."* And the furniture store appendage was.to become a separate business.

In 1931, Otto's nephew, Hollis, came into the business and in 1937, the two men bought the Lewis Bose mansion on North Michigan Street. "Huge white Tuscan columns rose twenty feet high

 in sheer beauty to the roof of the double-deck porch."* Beautiful hand-carved fireplace mantles high lofty ceilings, ornate balustered stairways. statuary and stained glass windows add a traditional dignity to the symetrically designed building. The Grossmans have preserved the beauty of the building while they have added the newest equipment necessary for their business.

With the expansion of the business, Mrs. Hollis Grossman, Ruth Myers Grossman, decided to study for her license and in 1949, she too became an accredited funeral director. Mrs. Grossman and Miss Ruth Spencer, an associate in the business for many years, ably supported the business during Hillis' army career. Otto's failing health made it impossible for him to share the responcibility of the business and his great nephew, Bob, helped in his place.

Otto Grossman died in 1958 and Mr. Hollis Grossman continued in the profession until his death in 1974. The family tradition is being maintained by Robert E. Grossman who officially entered the business in 1960.

Following a tour of duty in Korea. Bob was associated with General Motors for three years before coming full-time to the business. Bob and his wife, Bonnie, have two young sons, Chris and Greg.

With two young Grossmans coming on, the Grossman name may continue to add historic dignity to Argos and to the family tradition.
