Taste of Culver fest June 14

Proskey, Biernacki, Berndt among host of changes in lead positions

A host of changes in faculty and administration at Culver Community Schools include a new face behind the principal's desk at Culver Elementary, and a sharing of the assistant principal and athletic director positions at Culver Comm. Middle and High Schools, among other changes.

In the elementary principal position this fall will be Erin Proskey, current elementary assistant principal.

Current elementary principal Chuck Kitchell, who has served at the post since 1997, will become Director of Operations/ Focusing on Curriculum, according to Culver Comm. Schools superintendent Dr. Vicki McGuire.

"Chuck Kitchell will move into a role that will allow him to support all principals and teachers with implementation of the new state standards," says McGuire. "Mr. Kitchell will also be available for any principal who may need extra assistance with disciplinary issues or other areas that require support such as

Council will meet with plan commission concerning wind devices

Culver's town council breezed through a fairly short meeting last week, though members did schedule a public work session for 5 p.m. June 10 to seat both the council and Culver's plan commission in the same room in hopes of finding an agreeable way forward regarding the much-discussed (and debated) matter of personal use wind energy conversion systems, otherwise known as windmills.

That meeting was scheduled at the specific request of plan commission president Barry McManuay, who noted a sit-down between the two groups was discussed respectively by both in recent weeks.

Some controversy took place at a town council meeting last month when a number of residents pressed the council to vote against proposed specifications for the devices as proposed by the plan commission, which spent a number of months hammering out proposed legislation for council approval. After more detailed discussion at a more recent council meeting, however, council members changed gears and voted not to request a total ban on the devices by the plan commission.

The public is welcome at the meeting, which will take place at town hall.

The ceremony was part of Alumni Reunion Weekend, in which Gignilliat and his 23 returning 1949 classmates set an attendance record for a 65th reunion class. Also joining him was his wife, Ellen, and their three daughters, all of whom attended Culver: Suzanne SS'74, Bibby'78, and Mary SS'82.

"Paul Gignilliat was destined to be a Culver man," Head of Schools John Buxton said in his introduction at the all-school assembly.

His great-grandfather was Col. Alexander F. Fleet, who brought 72 cadets from Missouri in 1896 to bolster the Culver Military Academy enrollment. Gignilliat's grandfather, Gen. Leigh R. Gignilliat, orchestrated Culver's participation in the Logansport Flood and its participation in the Presidential Inaugural Parade in 1913, as well as the development of the Woodcraft Camp in 1912.

As a CMA student, Gignilliat was a member of Company D, a varsity boxer, member of the Cadet Club and Honor Guard. He attended Yale University, where he majored in history and lettered in crew. He was a member of the Naval ROTC program at Yale and later served two years aboard a destroyer escort in the Great Lakes.

He made his career in the stock market as a broker and

to install an ADA-compliant ramp on the sidewalk outside the building. She said the new rap would replace the planting box currently located outside the front door. A steel railing will be installed with the ramp.

Statczar also requested permission to install a hanging sign on a pole between the door and window, something she must discuss with the building commissioner, according to McManuay. The council approved the sign pending the commissioner's approval, but opted to table the ramp until town utilities manager Bob Porter and town manager Dave Schoeff could inspect the site and approve the specifications for it.

TIF expansion

Kathy Clark of the Culver Redevelopment Commission discussed the proposed expansion of Culver's TIF (Tax increment financing) district, which would include 19 properties in town and three outside town limits, which were approved recently by the Marshall County commis-

A resident of Chicago, his accomplishments as a volunteer and community leader are far-reaching: school board president, trustee with the Chicago Symphony, director of the Chicago Humanities Festival, and a director for the Hubbard Street Dance Company.

"His service to Culver is even more impressive," Buxton noted: a trustee of The Culver Educational Foundation for 34 years, a former Legion board member, national Annual Fund chairman in (1986-88), Fine Arts Advisory Council member, Summer Schools & Camps Strategic Planning and Development Committee member, and an honorary member of Culver's Cum Laude Society.

But it is the Gignilliats' love of Culver and appreciation of the fine arts that have combined to benefit students and faculty in numerous ways.

"Some might say that Paul and Ellen have been Culver's Patrons of the Arts," John said. "Their Culture in Chicago program has introduced literally thousands of students and dozens of faculty members to the wonders of cultural life in the other place they love and call home – Chicago."

The Artistic program funded by the couple has made it

possible for aspiring artists – students as well as faculty and art mentors – to get supplemental training to advance their skills.

Their support has given the choir opportunities to travel the Mozart International Choir Festival in Austria and the Rome International Choir Festival. Individually, they have assisted four students selected for the Honors Choir at Carnegie Hall.

Additionally, through a Permadebt program, the Gignilliats have helped young faculty members eliminate portions of their college student loan debt.

The results of their work was seen and heard at the Graduate of the Year Ceremony. It included musical performances by a student, a faculty member, and the Culver Choir, all of whom have benefited from their generosity.

Gignilliat also has been a supporter of the summer Naval Band and other camp programs. His patronage even extends to "the trees on campus, who replaces or doctors our beautiful trees to keep the campus majestic," Buxton said.

sioners.

The area includes a number of longstanding businesses as well as a row of properties on Main Street between Washington and Cass which are currently private residences but are zoned for commercial use (Clark noted the CRC would gain no money from the latter properties unless their use actually becomes commercial).

Clark also explained any of the properties were not included when Culver TIF districts were established in 2003 because TIF was largely unknown in the area at the time and the CRC "didn't just want to take everything industrial or commercial in town...now we're trying to pick up things where we might see development in the next ten years."

She added development is already in the works at some properties such as CVS and the new bakery, but the CRC simply wishes to "have a voice" in future development in coming years.

Other areas include land on the west side of South Main Street (around the Garden Court senior living facility) and West Jefferson Street east of State Road 17, two areas Clark noted have been examined as potential for moderate income housing development.

Council president Ginny Munroe noted the Culver plan commission has already approved the proposal, which the council adopted by resolution.

Other business

Council also approved a request from Culver Military Academy cadets Landrum Neer and James Jamison to use the town-owned lot near the Lake Shore Drive water tower for a 'wake and wash' boat and car wash June 27 and 28, a senior service project which will raise money for Culver's Lions Club.

Neer noted the students will likely use his uncle's trailer and tank to supply water.

During his town manager's report, Shoeff said repairs at that water tower are complete and the tank in the process of being refilled.

A public hearing will take place June 17 prior to final approval of Culver's new comprehensive plan, he said. He also reported an income survey needed for the town to qualify for requested grant funds is complete, with results coming back that the town is 57 percent low to moderate income.

Approved by council was \$6,500 to finish milling out and paving areas of Cass and Slate Streets and Lake Shore Drive in order to attain uniformity of paving. The areas adjoin portions of those streets which were dug up and repaved as part of the nearly complete storm water project on Culver's west side.

A quote from Thomas Excavating for \$24,672 was the low bid to install a controlling structure to prevent increased water flow going west outside of Culver following completion of the storm water project, a requirement of the Marshall-Starke County drainage board, according to Schoeff. He noted town representatives tried in vain to argue against the need for the structure.

A work session was scheduled by the council for June 24 for a presentation by community calendar business What's Up 24-7.

Deer, speed reported as factors in damage at Burr Oak cemetery

A single-vehicle accident destroyed a large cement pillar at the entrance to the Burr Oak Cemetery on 14B Road west of Tulip Road, according to the Marshall County Sherrif's Department.

Officer Joe Giordano investigated a call around 4:30 p.m. May 31, where it was reported a 1993 Dodge Stealth driven by 20-year-old Dillon Smith of Plymouth had been traveling westbound on 14B Road. Smith's vehicle crested the hill just east of the cemetery and ran off the road to the left, striking and destroying the pillar, on the south side of 14B. Dillon said he had swerved to avoid a deer. The Sherrif's Department adds that unsafe speed also appeared to have been a factor in the crash. There were no injuries, and the accident is still under unvestigation.

Culver Community girls track team headed to State

WARSAW — About this time a year ago, Kayla Shaffer wasn't even thinking about the state track finals.

"I played softball when I was a junior," says the Culver Community senior. "I didn't run track; I never really thought about it."

My, what a difference a year makes. Now, Shaffer isn't just thinking about next week's state track meet.

She's thinking about winning it.

"What have we got to lose? We'll go all out," said Shaffer, who led a remarkable Cavalier surge Tuesday at the Warsaw girls track regional.

In particular, the 100-meter dash, where she and senior teammate Denisha Brown pulled off a stunning 1-2 finish, clocking 12.54 and 12.57 seconds, respectively.

Culver Community. One-two. In a regional 100 meter dash.

"We might go 100 years before you see Culver finish 1-2 again in the 100-meter dash at a regional," said Cavaliers coach Mike Buschman. "For us, what an amazing accomplishment.'

But that was just the start. Brown went on to finish second in the long jump, just two inches behind champion Shawntel James of Jimtown.

Shaffer clocked 25.51 in the 200-meter dash, leading most of the way until South Bend Riley's Ayiana Gaines

slipped past, a few feet before the finish line.

Shot putter Mickella Hardy, a junior, finished third, reaching 39-11 3/4". The Cavalier 4 x 100 relay of Shaffer, Hardy, Justine Dexter and Brown finished fourth in a blistering 49.54 seconds.

Add it all up, and Culver Community finished fifth in the final team standings, square in a battle with Mishawaka and South Bend Adams.

Warsaw won the regional championship with 67 points, while Penn placed second at 60-1/2. Culver Community scored 46.

"You just don't see us do things like this very often," said Buschman. "Denisha is just coming off a foot injury. "We've had to have a lot of things go right."

At least the Cavaliers can count on being well-represented at the IHSAA girls state track finals in Bloomington on Friday, June 6.

The top three finishers in each event advance to state, as well as anybody who meets a tough IHSAA performance standard.

Plymouth is sending athletes to Bloomington in two events, starting with high jumper Kaydon Fosler, who cleared 5 feet, 2-1/4 inches to claim a regional championship.

Wright placed fifth in the 800-meter run, leaving her short of a state berth. But she helped Plymouth score 20 points, good for 11th overall.

Culver Academies weight thrower Leah Heckaman wasn't feeling her usual self Tuesday and was upset by Lakeland freshman Kloee Fitch in the discus. Fitch threw 140-8, Heckaman went 132-2.

In the shot put, Heckaman won with a 42-8 1/4 toss Very good, but still a foot shy of the regional record she was hoping for.

"I really don't know what happened," said Heckaman. "I put too much pressure on myself. I was thinking about it too much.'

Academies Memorial Day speaker emphasizes sacrifice, complexity of American soldier

By Jan Garrison, Culver Academies Capt. James McLaughlin, CMA class of 2006, was the guest speaker at Culver Academies' Gold Star Ceremony on Memorial Day where he spoke to the students, faculty, staff and guests gathered in the Memorial Chapel on May 26.

McLaughlin is a 2010 graduate of the United States Military Academy, receiving his admissions offer through Culver. Upon graduation from West Point, McLaughlin was commissioned as an infantry officer. After completing the Infantry Officer Basic

"Golden Dragons." He served as a Rifle Platoon Leader, deploying to Afghanistan in support of Operation Enduring Freedom. He is currently assigned as the Battalion Assistant Operations Officer.

His military awards and badges include the Combat Infantryman's Badge, the Ranger Tab, the Basic Parachutist's Badge, the Army Commendation Medal, the Army Achievement Medal (with Oak Leaf Cluster), the Afghan Campaign Medal (with Star), and the Global

War on Terrorism Service Medal. In his speech, McLaughlin em-

phasized putting one's self second-



ary to whatever is being asked and the "willingness to give up what matters to you without hesitation, despite reservation."

He also pointed to the value of imperfection, noting that "joining the military doesn't correct (one's) flaws or change their vices. It does highlight the good in man, especially when adversity is applied, and it more importantly imbues them with a deep sense of honor. But despite all of the good the military does, there is bad as well."

He suggested that, rather than idolizing veterans, they should be seen as full persons, good and bad.

...Despite the success or failure, the true humanity of the American soldier to me is far more remarkable than any myth or any story. We should apply that same thought to Culver's Gold Star men."

He also remembered West Point classmate and friend 1st Lt. Todd Lambka, who died in 2012 when his vehicle had struck an IED. McLaughlin said soldiers like Lambka should be honored, "But we should never be sad at their passing. We should strive to learn what their service truly meant to this country, and be in awe that such men were Americans."
