Remember Jack's Grill on the corner of LaPorte and Center in Plymouth, Indiana? The grill, owned by Mary Wallace of Plymouth, was bought by Bob Listenberger in 1952. Bob, his wife Rosemary, and a staff of three ran the restaurant from 1952 to 1964. Bob recalls the business being slow the first two years, "So slow in fact, I was tempted to give up and sell."

Bob describes the next ten years in the grill as good years due to increased business which he attributes to the railroad workmen. The crews coming through Plymouth on Sundays at 2 A. M. had no place to eat. Bob offered to stay open for the railroaders and these men became not only 2 A. M. customers, but the customers of all the meals served at the restaurant. The men worked shifts and there was always a railroader at the daily meals.

"After twelve years at that location,"Bob said,
"I decided I would like to try a larger restaurant. The Holiday Inn was being built north
of Plymouth on old route 31 and, with The State
Exchange Bank's help, I leased the restaurant
space. We opened in 1965 and had a dining
room which would accomodate 92 people. The
private dining room had space for 240 people.
Quite an increase from our grill which would
seat 50!"

Bob's restaurant at the Holiday Inn was remodeled and enlarged in the fall of 1976. In November, the Balloon Wurks Restaurant was officially opened. The remodeling enabled Bob to increase the seating capacity of the dining room to 125 and the private dining area to 270 seating capacity. The new enlarged lounge will seat 106 people.

Bob's staff also increased in the move from the grill to the Inn. From the five people at the grill, which included Rosemary as the cook and Bob as manager and handyman, the staff at the newly remodeled restaurant has grown to 62 people. There are seven cooks and a manager, Bill Mueller, to help Bob and Rosemary. (Rosemary is now in the office).

Mr. Listenberger wanted to make sure that the people employed by him were given credit for the Balloon Wurks Restaurant's success, "Without people like Ed, our long employed chef, and waitresses like Ada and Bobby, we just couldn't open our doors."

Interest in ballooning inspired the name "Balloon Wurks." There is a balloon replica hovering over the buffet table. Sunshine colors brighten the breakfast area which overlooks the Inn pool and a balloon motif enriches the comfortably furnished dining room.

The main attraction in the lounge is an 18 ft. mural depicting ballons in flight. It is of stained glass illuminated from behind so the balloons have a three dimensional effect. The decor of the lounge echos colors in the mural and the record counter

for the discotheque is displayed under a huge balloon canopy.

Bob was modest in his description of the food changes he has made from the grill to the Inn. Our Plymouth State Exchange Bank employees can testify to the delicious meals prepared for the luncheon trade. The evening menu includes cuisine of which any fine restaurant would be proud. Prime rib is a special treat as are the crab legs, lobster, crepes, cream sauces, and delicately rich desserts. (Be sure to try the baked potato with "ALL".)

One of the Holiday Inn Restaurant's first big events was the opening of our Plymouth Bank in 1966. Mr. Listenberger catered the food and service for the affair. There were buses to shuttle people from our bank to the Inn for the buffet supper on two consecutive evenings.

"The bank has always been good to me in not only financial matters" Bob said, "On an occasion or two on Saturdays, I've called Ron McKee and asked if a large convention group could have their meeting in the bank lounge after banking hours. We hated to impose on friendship but were desperate as the restaurant was just too full to give the convention meeting space. We hope we can take care of this type of problem in our new 270 seat banquet room.

Bob Listenberger is an entrepreneur in the food business. Not only does he have the Holiday Inn Balloon Wurks in Plymouth, he has Colonel Sanders Fried Chicken restaurants in six Indiana locations: Angola, Rochester, Lebanon, Mooresville, Fortville, and Elwood. Bob's family corporation is involved in the fried chicken franchises as well as a new acquisition, Union Station Tavern west on LaPorte Street in Plymouth.

"I enjoy the food business and do thank The State Exchange Bank for their part in our business success!" Bob exclaimed.

We thank the Listenbergers for giving Plymouth one of the finest restaurants round and for giving our bank the opportunity to serve them!
