THE NEWS IS OUT!!

Bremen has been chosen by the Farmers State Bank to be the site of a branch bank. The application is in for the proposed bank, and approval must be made by the State Banking Commission and the Federal Deposit and Insurance Department before final plans can be made.

There are many rules and regulations connected with the approval of the site. A branch bank in Indiana must be located in the county of the home bank and outside the city limits of a town with an existing home bank. (The Plymouth bank came under this law). A community must be evident (meaning a location where there is traffic warranting the banking service to the people.)

The proposed site for the bank would be north of Bremen on Route 331. There are over 85 homes in a radius of 4 miles on this side of Bremen and plans are under way for more family dwellings.

The location of the new by-pass for Hwy. 6 has been determined. This new road will be ½ mile north of the proposed banking site. Availability to the banking services would be excellent.

After a bank sends in an application, there is a waiting period to allow other people to remonstrate against the application. An objection has been filed which will mean that there must be a hearing to review both sides of the case

Al Cummins has been in charge of preparing the application for the branch. He has spent many, many hours and with the assistance of Bill Annis and Burl Nyfong, prepared an excellent application, according to the department of financial institutions.

Al and Fred Adams have worked together with the department and, with the help of John Deery, are now coordinating their efforts with an Indianapolis attorney to prepare our case for the hearing. The Indianapolis attorney is considered the outstanding specialist in this field in Indiana.

The directors of our bank are solidly behind locating the branch in Bremen. It is their opinion that this new office would substantially increase our business activity at the Farmers State Bank and would better serve our present customers such as; TV Time Foods, and many other commercial and individual customers

HOOSIER HOSPITALITY

Wednesday, November 4, twelve ladies from Marshall County were entertained in the official residence of the Governor in Indianapolis. Mrs. Bowen had invited the ladies to a luncheon to thank them for their contribution to the home. They each made a needle-point dining room chair covering last spring and presented the seats to the Bowens as a special gift from their county. The luncheon was a "Thank You" for the gift.

The new residence of the govenor is at 4750 North Meridian St., about three blocks south of the former residence.

The circular drive east of the home leads guests to the main entrance where two stately sculpt lions greet guests. The former portico of the home has been converted into a glassed-in foyer to the home. The beautiful orientals, stately oak chairs are blended with live green plants, both hanging and in pots. There is a long side board against the south wall of the foyer, above which hangs a watercolor painting of the Bowen's Bremen home. The painting is done by a Bremen artist.

Heavy oak paneled doors open into the entrance hall of the home. The doors are especially noteworthy for they came from the old State Mental Institution Building. The massive brass hardware on the doors is beautiful!

Describing the home in brief: The entrance leads up three steps to a large hall. To the right of the hall is the dining room, kitchen, and the apartments for Mrs. Bowen's secretary and the domestic help.

To the right of the main hall is the den (it faces Meridian Street) and straight ahead, down two steps, is the living room. The walls and carpeting are in a shade of sauterne (pale beige) The colors of the furnishings are blends of burgundy, blue, rust and cinnexon brown. At the opposite end of the large room, is a fireplace. On the left is an ornately hand painted grand piano which was donated to the home in the lat 1800's by an Indiana patron.

Also, a key spot in the room is graced by a large 12' by 6' glassed hutch in which are displayed antique, Indiana commemorative plates collected by the Ball family of Muncie and given, with the hutch to the Bowens for the new residence.

A circular staircase curves up at the side of the main hall leading to the private quarters of the govenor and his family.

An interesting note on the guest rooms: one room is named "The Burr Oak Room" in honor of Bob and Dorothy Osborn. President Ford stayed in this room on his visit to Indianapolis. Another guest room is named "The Shalley Drive Room" in honor of Bill and Lynn Gee. Both couples are close friends of the Bowens.

The outside grounds of the home are extensive and, with thoughtful consideration to cost, are well planted. There is included; extensive alarm systems, lighting, and security devices. giving maximum safety to the home.

Mrs. Bowen pointed out many rare pieces of furniture and paintings which have been donated to the govenor's home.

She told the ladies that she had enjoyed helping to plan the home and the furnishings for the new residence.

The official residence of the Govenor of Indiana is a warm and friendly home just like the people who live in it, the Otis Bowens.
