#### JUNIOR WOMEN LEARN ABOUT THE KIDNEY FOUNDATION

The Maxinkuckee Junior Women met Monday evening in the home of Mrs. Michael Overmyer. The evening's program was presented by Mrs. Linda Rozanski, Secretary, Mr. James Nolen, Vice President of the North Central Chapter, Indiana Kidney Foundation, and Mrs. Nolen. Mr. Nolen is a kidney transplant recipient and told the group of the problems and needs of patients on dialysis machines, kidney transplants, and the need more kidney detection

Mr. Nolen reported that kidney disease is the fourth major health problem in America. In Indiana, 1,700 people die yearly of kidney disease. In 1972, 61 patients received kidney transplants and about 250 are waiting for a transplant. He also noted that over 75% of the functions of the kidneys made. It is the hope of the local club to sponsor a detection clinic in the near future for Culver area residents. This is a project of the Federated Women's Clubs.

It was voted by the club to make a contribution to this chapter of the Kidney Foundation.

#### ENERGY INFORMATION AVAILABLE BY PHONE

The public can now dial a new telephone number and receive round-the-clock energy informa-tion, Second District Congressman

tion, second District Congressman Earl Landgrebe reported.

The new number is 202-634-7610. According to Landgrebe, it can be dialed from any point in the country, and is staffed by a team of information specialists to answer questions on the allocation program and FEO fuel rules and regulations. The public and industrial and business leaders are also directed by the service to potential sources of help on complaints about price gouging and other practices.

The Telephone Inquiry Section

was established late last year to provide businessmen and the general public with 24 hour-a-day energy information. Since then, than 27,000 calls have been recorded by the Telephone Inquiry Section. The number of calls has so taxted the present facilities that the new number set-up was instituted. Its 16 rotary lines, it is hoped by Federal Energy officials, will better be able to serve both the business community and the general public.

In business from the floor, Bonnie Voreis expressed her appreciation to Mr. McFeely and the Street Department for cleaning the banks along the lake from the viaduct south.

Under old business Chief Overmyer reported that a fire truck made by Universal Fire Equipment Company had been inspected by Fire Department officials. Overmyer felt that the truck had several weaknesses, among which that the motor had to be revved very hard to pump water effectively. The board will advertise for a re-bidding for the truck.
