CCHS' Klimaszewski named 2015 Lilly Scholar

Culver Community High School student Haley Klimaszewski has been named recipient of a four-year, full tuition scholarship as the Marshall County Community Foundation 2015 Lilly Endowment Community Scholar. Klimaszewski will receive full tuition to the Indiana college of her choice and a \$900 yearly stipend for required books and equipment.

Klimaszewski is the daughter of Lou and Lori Klimaszewski of Culver, and is planning to attend Indiana University Bloomington and will major in Genetics. She eventually hopes to earn her PhD in the subject and focus on studying DNA as a geneticist.

CCHS English instructor Vickie Benner recommended Klimaszewski for the schol-

"I can always count on Haley to provide engaging and insightful perspectives in class discussion," she said. "Haley maintains a positive attitude about her education and is self-motivated. I appreciate Haley's integrity and sense of commitment.

"Haley is driven to succeed," added Benner. "She sets goals for herself and carries through on them."

An emotional Klimaszewski, who was called last Wednesday afternoon to the school cafeteria to receive the award, said her receipt of it was a surprise to her.

"It's so exciting," she told The Culver Citizen. "I feel like I worked for it for the past four years and even before that, in middle school, I was working to get good

"I'm really excited to have so many people at the school support me so much," she added, offering specific thanks to Brenda Sheldon and Sandy Master, both of the school's guidance office, for their encouragement. She also thanked the Lilly committee.

And, she says, "I can't believe my mom kept it a secret!'

Klimaszewski's mother, Lori, expressed

pride on behalf of her whole family.

"She's dedicated and devoted," she added. "We couldn't ask for a better daughter."

"It just goes to show the dedication the staff (at CCHS) has to the students and the community, and parents have to the school," said Community Schools superintendent Dr. Vicki McGuire. "She deserves lot of congratulations; she has worked so hard for it.

"She's going to be a really great leader," McGuire added. "We need more people

CCHS principal Brett Berndt concurred. "I'm extremely excited for Haley," he told The Citizen. "She is one of a kind. She's an awesome, very hard worker in the classroom and outside of it. She's an outstanding leader and a great role model for

every student in the school to try to attain to. We're extremely proud, and we're glad she's one of ours." Klimaszewski is the school's fifth Lilly

Scholar, the most recent before her being Myles Pinder, in 2009. Klimaszewski is a familiar face in Culver, partly to many through her work at Cafe Max on Main Street here.

At the school, she's been president of the National Honor Society, Business Professionals of America, Culver Alliance for Voluntary Service and of her class. She was chosen as a Girls State delegate and as CCHS' HOBY leadership representative.

She is also president of the school's community service organization, Culver Youth Community Organization and has participated in a variety of service projects, from collecting food for the Food Pantry, helping in the town-wide cleanup, Lions Chili Supper, Relay for Life and the Logan Nose On (for handicapped adults).

Klimaszewski has also distinguished herself for her writing prowess, wining the VFW Voice of a Democracy Essay award. among other

release party here

Cover art, publication date released SUSAN @ EWIS Place Hide

By Jeff Kenney Citizen editor A publication date, cover art. and release party have been scheduled for a novel set in Culver and written by best-British selling novelist Susan Lewis.

The book, titled, "No Place to Hide," will be released July 28, and a launch party is slated to take place Saturday, Aug. 1 at Cafe Max, 113 Main Street in downtown Culver

to which we all be invited.

Lewis (www.susanlewis.com) spent some time in Indiana last September researching this novel, which involves a young woman and her child changing their names and trying to make a new life to escape what they've left behind. They didn't expect what was waiting for them in Culver. The book is largely set in the town, although all local characters are fictional. She was recommended to visit Culver last year by old friend Chip Mitzell, whose

connections to the Culver community run deep. Lewis interviewed a number of locals, including businesspeople, police, and the editor of The Culver Citizen,

during her stay. The author has written more than 30 books, including two memoirs, many of which regularly make the London Times top ten bestseller list; her books have been translated into multiple languages, and she has a loyal fan-base in her native country.

"I didn't expect anything like this jewel of a community," Lewis told *The Citizen* during last year's visit. "I was pleasantly surprised and intrigued by the immense wealth of all kinds that's here. It makes it an extremely interesting place to write about, because it's not all one thing.'

Culver's Sayger receives Hall of Fame centennial award

Lauded as inventor of three-point shot, record-holding scorer, more, at March 25 awards ceremony

NEW CASTLE, IND - A Culver man was recognized for his remarkable contributions to not only Indiana basketball but to the sport nationally last month. The Indiana Basketball Hall of Fame lauded the late Herman Sayger among others of its 54th class of inductees on March 25 in ceremonies held at Primo Banquet Hall in Indianapolis.

Culver's Sherrill Fujimu-

ra accepted the award on behalf of her "Uncle Herman," a 1914 Culver High School graduate.

The award came alongside a detailed article, by Kyle Neddenriep, in The Indianapolis Star newspaper (published online March 24 -- available here www. indystar.com/story/sports/ high-school/2015/03/24/ originator-point-shotremembered-visionary/70373740), which validated for the first time that Sayger was indeed the inventor of the three-point shot in the sport.

Carving out the legend

As reported in a feature on Sayger in The Culver Citizen of Sept. 17, 2009, Sayger still holds the Indiana high school individual scoring record with 113 points in a 154-10 victory against Winamac in March,

In fact, the 1914 CHS team, which consisted of only five players and no reserves (besides Sayger, the team also included Rex Mawhorter, Charles Cowan, and Tone Shaw), won 25 out of 27 games that season and amassed over 1,300 points, making it to state semi-finals. There the team won their first nine

games and lost by just one point.

Born in Jonesboro, Arkansas in 1895, Sayger lost his parents Larry and Emma and brother Gene within a week of one another while he was a young child Emma Green Sayger's sister Mary had married Tom Medbourn of Culver, and the couple took young Her-

ponents."

man in, bringing him to Culver around 1901 to be raised alongside their own children Charlie and Myrtle, more or less as a brother.

Recalls Sher-Fujimura, her mother Donna (Medbourn) Edgington always called Herman Sayger "Uncle Herman," a name Sherrill herself adopted for him as well.

"In his senior season," noted Indiana Basdirector May during the

induction speech at last month's awards, "Sayger had games of 79, 55, and 52 pointed and scored 56 percent of his team's points for the season. That year, Sayger was named 1st Team All-State as he averaged 29.5 points per game, compared to 16 points per game for Culver's op-

It was in Culver, of course, that Sayger played that record 1913 game against Winamac, though he also played a year for Culver Military Academy on a scholarship as well, becoming a football, basketball, baseball, and track star there as well as a coach after graduating high school in 1915. That fall he entered Heidelberg College in Tiffin, Ohio, participating in a host of sports there and making All Ohio in football and basketball.

The Heidelberg College basketball court in Ohio is named in Sayger's honor after he launched the school's intramural sports program, serving as athletics director and head football coach there. The Sayger Award is presented each year to the college's senior male athlete most likely to succeed.

Originating the three-pointer

As also reported in *The Citizen* in 2009, Sayger was often credited as the first to suggest the three-point rule in basketball while coaching in Tiffin. The rule was intended to eliminate the center jump and establish a new scoring system, and eventually was adopted permanently on the professional level following its 1945 testing in the NCAA.

Thanks to the *Star*'s research endeavors (credited to Star librarian Cathy Knapp), that claim has been proven.

An article from The Tiffin Advertiser in March, 1932 documents an exhibition game between Tiffin Junior Home and Tiffin Columbian high school basketball teams which included Sayger's rules that "a shot from beyond 25 feet was worth three points and a shot inside of 15 feet worth one point. Anything in between counted for the traditional two points," according to The Star, which also notes he eliminated the jump ball after each basket, hoping to reduce the extent to which the game leaned towards height instead of skill as its determining factor.

Sports headlines of the day recognized the change as indicative of a new style of basketball which the Coshocton (Ohio) Tribune described as working "to help out the midgets and reduce the power of giraffes.'

Sayger continued to employ the new scoring scheme in years following, with a 1935 game in Columbus, Ohio, showcasing it to its widest audience yet, apparently effectively, as a number of coaches were encouraged to jot down their opinions of the scoring system.

"In the mid-1930s," May also said during his Sayger induction speech on March 25, "Sayger made another change to the game that would be adapted much more quickly: he advocated eliminating the center jump after each basket. He included this wrinkle into his exhibition games in 1935 and by 1938, the rule was changed."

The Star article, calling Sayger "likely far ahead of his time in this regard," notes he also attempted to eliminate stalling tactics April 11-12, 2015 in the game during a 1936

endeavor. That idea didn't take off.

The three point line didn't arrive until years later in basketball. The American Basketball Association did popularize the three-point shot in 1967 and it was formally adopted by the NBA in 1979. It was adopted into college basketball in 1986, and in high schools in 1987. By then, most had forgotten Sayger's initiation of the rule.

Football legacy

Sayger's name also belongs in the annals of college football as well.

In 1917 he was captain of Heidelberg's football team and since the school's coach was otherwise occupied serving in World War I, Sayger coached basketball, football, and baseball for the school, making him possibly one of the only men to serve as quarterback, team captain, and coach of the same football team. Sayger himself was also called to service, playing football and basketball at Camp

He also coached swimming for 12 years at Culver Military Academy. Among other activities, Sayger returned to Heidelberg as coach after graduation, heading up two undefeated teams at the school.

Sayger also played professional football and went into sports writing, radio announcing, photography, drawing, and publication. He published an annual booklet illustrating the first football hand signals, established by Sayger himself and also published some 24 books on athletics. He assisted Red Barber in broadcasting college football games, was a member of the American Football Coaches Association most of his coaching life, and was a charter member of the National Football Hall of Fame in addition to starting a sports syndicate of his own.

He was associated with sports legends such as Knute Rockne, Red Grange, Jim Thorpe, and others.

"Uncle Herman"

Herman Sayger would go on to head launch Sayger Enterprises, Inc., which combined his camera store, studio, printing shop, publishing business, and other endeavors in addition to his work with O.K. Rubber Welders, whose Culver location may be remembered by many Culverites (the business was owned by Harry Edgington and Charles Medbourn of Culver). Sayger was a beloved member of his Tiffen, Ohio community, contributing locally in many capacities there up to his death in 1970.

Sherrill Fujimura knew "Uncle Herman" all her life and has fond memories of his kindness. His ashes were scattered over Lake Maxinkuckee.

Following an introduction by CES principal Erin Proskey, Culver police officer John Duhnowsky, who taught the 10-week DARE (Drug Abuse Resistance Education) program at the school, offered his thanks to Culver town marshal Wayne Bean for Bean's support of the event. Duhnowsky also thanked the school corporation, adding CES is "the best school to teach in...because everyone here is working together."

The DARE program was updated, Duhnowsky said, a few years ago with the theme altered to "Keeping it Real," which emphasizes acting out potential real-life situations students may face, in order to help them plan ahead and display confidence when faced with negative peer pres-

Duhnowsky said he was "really encouraged by the (student) essays...I felt many students this year were reached."

He added he's been teaching the program in Culver for 15 years, and has had an opportunity to teach it to anyone here under the age of 26, some of whom come up and thank him, noting how helpful the program had been for

The keynote speaker for the event was Bob Rich of Culver, a Deputy Commander of Special Investigations for the Indiana State Police. Noting his own three children went to CES, Rich explained his work involves wiretaps, undercover covert operations, and meth teams.

"I see lot of sad situations," he told the students in the audience. "As kids get older, they sometimes make bad de-See DARE page 5

In Memoriam – Lisa Bianco

A guest editorial by Ray Gleason

I'm naïve!

After growing up hard scrabble on New York City streets, serving over twenty years in the Rangers and in the Infantry, and pulling three combat tours in Nam, I thought I never say that about myself.

I'm naïve!

In general, what led me to this realization is my training in the the Kosciusko County Reserve Police Academy.

This is a training academy for men and women who have volunteered to serve their communities as reserve police officers... in other words, taking the same risks and assuming the same responsibilities as full-time police officers, but serving on their own time and often without pay.

The academy itself is conducted by veteran police officers, who are state-certified law-enforcement trainers, and who conduct the academy on their own time.

You might ask why these reserve officers do this. Or, why the full time officers dedicate hours to training others when they could be spending it with their own families.

If you were to ask, you might receive many different answers. But, I believe one answer would be common to all these dedicated men and women... to keep their communities safe.

If you were to ask further, "Safe from what?" you would be betraying the same degree of naiveté that I possessed when I started this journey.

For years, I have been functioning in my community... driving to work, running various errands, going to movies and restaurants... you can fill in your own blanks. For the most part, crime was invisible to me... never been assaulted... never witnessed a robbery... someone once

tried to mug me in Cincinnati, but that didn't work out too well for the poor ne'er-do-well.

Certainly, I have never had to obsess about my safety or that of my family... except of course on Chicago roads.

I imagine, after a while living in this bubble of tranquility, one can go into denial about the existence of a very real evil that hovers all about us. What affords us that luxury are the men and women serving our communities as police officers... the "thin blue line" (without the whimsy of Rowan Atkinson) that stands between us and criminal chaos. Their very presence on our streets and on our roads dissuades criminals from attacking. The fear of arrest and punishment reduces crime, and keeps us safe.

So, as I stated earlier, thanks to the dedication of the police, I have never had to live in fear of the evil that exists in and preys on our society.

An ironic aspect about police work is that a sign of success is when nothing seems to happen! Law enforcement is most effective when it's invisible. Everyone is free to enjoy their lives without criminal, and often tragic, inter-

That was the general basis of my naiveté.

A couple of weeks ago, the reserve academy was conducting domestic and family violence training. As part of the lesson, we students watched the statement of Lisa Bianco to the police describing what her husband, Alan Matheney, had inflicted on her. When Lisa Bianco was twenty-nine years old, she

struggled with Matheney's violent and vicious attempts to control and dominate her. Bianco was a petite woman, about a foot shorter than her six-foot-tall husband, yet she endured multiple beatings at Matheney's hands. Matheney inflicted a seemingly endless cycle of terror

and violence on this poor woman. He would intimidate and beat her, be arrested, post bond, and return to abuse her again. Even after she divorced him in 1985, Mathaney continued to pursue her.

into hiding and wore wigs to disguise herself. But, Matheney continued to stalk her.

Shortly after their divorce, Matheney kidnapped their two daughters. Bianco filed a complaint against him; he was arrested in North Carolina several weeks later and extradited back to Indiana.

While out on bond for the kidnapping charge, Matheney accosted Bianco, bound her, raped and beat her in an effort to get her to drop the charges.

Sentenced to prison for simple battery in a plea agreement, Mathaney was granted an eight-hour pass from a state prison near Indianapolis to visit his mother. He used that opportunity to track Bianco down. He broke into her house, chased her into the street and, in front of the couple's two young daughters, beat Bianco to death with the butt of a shotgun as she pounded on a neighbor's door for

An officer, who was on the scene, told me that Mathaney had hit Bianco so hard and so often that the wooden butt and stock of the shotgun was broken into three pieces.

Watching this young woman's testimony to the police after Matheney had bound and raped her, was worse than

any Hollywood horror movie I have ever seen! First, what Lisa Bianco described was appalling. Her often tearful recounting of beatings, strangulation, rape, confinement, kidnapping – the horrors that Matheney in-

flicted on this young woman - seemed endless. Secondly, every one of these atrocious acts were real. There was no room for denial here... no tension building up to some dramatic catharsis... "Thank God, this isn't real!"

It was!

Had I not seen this, I would not have believed it possible!

Before hearing Lisa Bianco's heartbreaking testimony, I would not have accepted that any human being could act as Matheney did.

That is one of many specific examples of my naiveté. That is also a specific reason why I serve as a reserve

police officer in my community. The story of domestic violence in our community can

To paraphrase John Donne, Lisa Bianco's death diminishes us, for we are part of mankind. Therefore, do not ask for whom her funeral bell tolls. See Bianco page 5 It tolls for us.



New moped laws in effect in Indiana

New laws went into effect Jan. 1 regarding the licensing and registration of Motor Driven Cycles, previously known as mopeds and motorized bicycles.

For Class A MDCs, an individual must possess a valid driver's license with a motorcycle endorsement with an MDC - Class A restriction; or a valid driver's license with a motorcycle endorsement; or valid driver's license and a valid motorcycle learner's permit.

MDC Class B vehicles must possess either a valid driver's license or permit (no endorsement required), or an unexpired State of Indiana issued identification card with an MDC - Class B endorsement

Any Indiana resident over 15 years of age may obtain an MDC - Class B Endorsement. More information is available at www.in.gov/bmv/3220.htm.





Workman was not visible on the 1940 Census and no information was available on Bernice or Junior.
